ORDINANCE 18-1463

AN ORDINANCE TO AMEND THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF MILLTOWN CHAPTER XIV, PARKS AND RECREATION AREAS, SECTION 6.6(D) SMOKING RESTRICTION

BE IT ORDAINED, by the governing body of the Borough of Milltown, County of Middlesex, State of New Jersey, as follows:

Section 1. The Borough Code of the Borough of Milltown is hereby amended and supplemented so as to amend Chapter XIV, entitled "Parks and Recreational Areas" so as to amend Article 14, Section 6.6(d) "Food and Beverage Policy; Smoking Restriction" which shall read in its entirety as follows:

§14-6.6 Food and Beverage Policy; Smoking Restriction

- a. Alcoholic beverages are prohibited at the pool during regular operating hours or any extension thereof by the Director of Recreation or Pool Manager. No person shall be under the influence of any alcohol at the pool during regular operating hours or any extension thereof by the Director of Recreation or Pool Manager.
b. Alcoholic beverages are permitted to be consumed at the pool during adult parties sponsored by the Borough Recreation Department, subject to the following restrictions:
i. Any adult party at which alcoholic beverages are permitted to be consumed at the pool must occur at a time other than the normal operating hours of the pool.
ii. No persons under the age of twenty-one (21) years may be present at the pool at any time when alcoholic beverages are permitted to be consumed.
iii. Participants at adult parties are required to bring their own alcoholic beverages for consumption during adult parties. No alcoholic beverages shall be offered for sale by the Borough Recreation Department to participants during any adult party; nor shall any alcoholic beverage be distributed to participants by the Borough Recreation Department free of charge during any adult party.
iv. No alcoholic beverages may be consumed in the swimming areas.
v. Glass containers are prohibited at any adult party.
vi. The Borough Recreation Department shall not be required to obtain an alcohol permit, as provided for in subsection 14-2.4 of these ordinances, in order to conduct adult party under this subsection.
c. Food and beverages are only permitted in areas designated by the Director of Recreation or Designee.
d. Smoking is not permitted anywhere on pool property at any time.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. This ordinance shall take effect after second reading and publication as required by law.
