

**BOROUGH OF MILLTOWN  
ORDINANCE 18-1464**

**AN ORDINANCE FIXING THE SALARIES AND WAGES FOR VARIOUS POSITIONS OF  
THE BOROUGH OF MILLTOWN AND PROVIDING FOR THE MANNER OF PAYMENT  
THEREOF FOR THE YEAR 2018**

**BE IT ORDAINED** by the Mayor and Borough Council of the Borough of Milltown, County of Middlesex, State of New Jersey as follows:

**SECTION 1.** That the following salaries and wages shall be paid to the various officials and employees of the Borough of Milltown as are hereinafter specified:

<u>Position</u>	<u>2018</u>
Chief Financial Officer, Full Time	\$50,000-\$85,000/ year
Chief Financial Officer, Part Time Salary <i>Minimum 20 hours per week</i>	\$20,000-80,000/ year
Chief Financial Officer, Part time- Hourly	\$35-\$54/hour

**SECTION 2.** All employees of the Borough of Milltown shall be paid on Friday of every other week.

**SECTION 3.** Compensation for services of a special nature beyond the regular routine business of official officers shall be authorized by appropriate resolution.

**SECTION 4.** All ordinances or parts of ordinances inconsistent herewithin are hereby repealed.

**SECTION 5.** This ordinance shall become effective upon final publication as required by law.
