

**BOROUGH OF MILLTOWN  
ORDINANCE #18-1466**

**ORDINANCE PROVIDING FOR VARIOUS IMPROVEMENTS IN AND BY THE BOROUGH OF MILLTOWN, IN THE COUNTY OF MIDDLESEX, NEW JERSEY, AND APPROPRIATING \$40,000 THEREFOR FROM WATER AND SEWER UTILITY CAPITAL FUND BALANCE AND THE ELECTRIC UTILITY CAPITAL FUND BALANCE.**

**BE IT ORDAINED BY THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF MILLTOWN, IN THE COUNTY OF MIDDLESEX, NEW JERSEY, AS FOLLOWS:**

Section 1. The improvements described in Section 2 of this ordinance are hereby authorized as general improvements to be made or acquired by The Borough of Milltown, in the County of Middlesex, New Jersey. For the said improvements or purposes stated in said Section 2, there is hereby appropriated therefor the sum of \$40,000, of which \$20,000 will be funded by the Water and Sewer Utility Capital Fund Balance, and \$20,000 will be funded from the Electric Utility Capital Fund Balance.

Section 2. The improvements hereby authorized and the several purposes for the financing of which the appropriation is made as provided in Section 1 of this ordinance are as follows: (a) the replacement of the Public Works and Utilities radio system together with, for all of the foregoing, all site work, appurtenant equipment, accessories, attachments, work and materials, and all engineering, legal, advertising and other costs associated therewith, and all as shown on and in accordance with the plans and specifications therefor on file or to be filed in the office of the Borough Clerk and hereby approved.

Section 3. The capital budget or temporary capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services are on file with the Borough Clerk and are available for public inspection.

Section 4. This ordinance shall take effect after publication after final adoption, as provided by law.
