

**BOROUGH OF MILLTOWN  
ORDINANCE 18-1467**

**AN ORDINANCE FIXING THE SALARIES AND WAGES FOR VARIOUS POSITIONS OF  
THE BOROUGH OF MILLTOWN AND PROVIDING FOR THE MANNER OF PAYMENT  
THEREOF**

**BE IT ORDAINED** by the Mayor and Borough Council of the Borough of Milltown, County of Middlesex, State of New Jersey as follows:

**SECTION 1.** That the following salaries and wages shall be paid to the various officials and employees of the Borough of Milltown as are hereinafter specified:

Chief Financial Officer	Full Time	50,000	85,000
Chief Financial Officer	Part Time	10,000	50,000
Chief Financial Officer	Part Time, Hourly	\$35.00/hr	\$50.00/hr
Business Administrator	Full Time	75,000	150,000
Business Administrator	Part Time	12,000	60,000

**SECTION 2.** All employees of the Borough of Milltown shall be paid on Friday of every other week.

**SECTION 3.** Compensation for services of a special nature beyond the regular routine business of official officers shall be authorized by appropriate resolution.

**SECTION 4.** All ordinances or parts of ordinances inconsistent herewithin are hereby repealed.

**SECTION 5.** This ordinance shall become effective upon final publication as required by law.
