

## BOROUGH OF MILLTOWN

## ORDINANCE #19-1473

**AN ORDINANCE TO AMEND CHAPTER XIV, PARKS AND RECREATION, SECTION 6, BOROUGH POOL, SUBSECTION 6.3, FEES; AND SECTION 7, RECREATION PROGRAMS, SUBSECTION 7.2, FEES; OF REVISED GENERAL ORDINANCES OF THE BOROUGH OF MILLTOWN, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY.**

**BE IT ORDAINED** by the Borough of Milltown of the County of Middlesex and State of New Jersey that the Revised General Ordinances of the Borough of Milltown be amended as follows:

**Section 1.** Chapter XIV, Parks and Recreation, Section 6, Borough Pool, Subsection 14-6.3, Fees, of the Revised General Ordinances of the Borough of Milltown is hereby amended as follows:

**h.** *Waiver of Fees.* In the event that any individuals wishing to partake in the aforementioned events fall below the Federal poverty level, the Director of the Department of Recreation may waive these fees.

**i.** *Late Fees.* A late fee of \$15.00 shall be charged for any payment not received on or before the due date established for said payment by the Director of Recreation. The Director of Recreation is hereby authorized to waive the imposition of any Late Fee due pursuant to this subsection for good cause shown.

**Section 2.** Chapter XIV, Parks and Recreation, Section 7, Recreation Programs, Subsection 14-7.2, Fees, of the Revised General Ordinances of the Borough of Milltown is hereby amended as follows:

c. *Late Fees.* A late fee of \$15.00 shall be charged for any payment not received on or before the due date established for said payment by the Director of Recreation. The Director of Recreation is hereby authorized to waive the imposition of any Late Fee due pursuant to this subsection for good cause shown.

d. *Waiver of Fees.* In the event that any individuals wishing to partake in the aforementioned events fall below the Federal poverty level, the Director of the Department of Recreation may waive these fees.


e. *Non-Annual Programs.* Any programs or events not run on an annual basis by the Department of Parks and Recreation shall be at a fee established by use of the following equation: Cost of Program (based on minimum participation rate) + Administration Fee (10% of cost; not to exceed \$20)

**Section 5.** Each clause, section or subsection of the ordinance shall be deemed a separate provision to the intent that if any such clause, section or subsection should be declared invalid, the remainder of the ordinance shall not be affected.

**Section 6.** All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed as to the extent of such inconsistency.

**Section 7.** This ordinance shall take effect immediately upon adoption and publication according to law.
