ORDINANCE #18-1454

AN ORDINANCE OF THE BOROUGH OF MILLTOWN, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY, AMENDING CHAPTER 8 OF THE BOROUGH CODE OF THE BOROUGH OF MILLTOWN, ENTITLED "SCHOOL- AGED CHILD CARE PROGRAM"

BE IT ORDAINED, by the governing body of the Borough of Milltown, County of Middlesex, State of New Jersey, as follows:

SECTION 1. The Borough Code of the Borough of Milltown is hereby amended and supplemented so as to amend Chapter 8, entitled "School-Aged Child Care Program" so as to amend Section 8-3 "Hours of Operation" which shall read in its entirety as follows:

§8-3 HOURS OF OPERATION.

- a. The Milltown School-Aged Child Care Program will operate for twelve (12) months each year.
- b. School Year Program will operate at Parkview Elementary and Joyce Kilmer Elementary when school is in session.
 - i. The **Before-School Program** will operate from 7:00AM until school opens.
 - ii. The **After-School Program** will operate from school closing until 6:00PM.
 1. In the event of scheduled early dismissal, each program will operate from the time of early dismissal until 6:00 p.m.
 2. There will be no program after school in the event of early dismissal due to inclement weather or an emergency.
- c. Summer SACC Program will begin operating following the last day of school in June for Parkview Elementary and Joyce Kilmer Elementary and will continue through July and August
 - a. The Summer SACC Program will operate Monday through Friday from 7:00AM until 6:00PM
 - b. Summer SACC will not operate on Holidays.
 - c. Summer SACC will not operate in the event of an emergency.

SECTION 2. The Borough Code of the Borough of Milltown is hereby amended and supplemented so as to amend Chapter 8, entitled "School-Aged Child Care Program" so as to amend Section 8-4 "Fees" which shall read in its entirety as follows:

§8-4 Fees

- a. **School Year Program.**
 - i. The School Year SACC Program is available to Milltown Residents.
 - ii. There is a School Year registration fee of forty (\$40.00) dollars nonrefundable fee per child.
 - iii. SACC Fees shall be paid in equal monthly installments due by the 25th of each preceding month during the school year. If the due date falls on a weekend or holiday, the payment will be due by the following business day.
 1. **Before School Program Fee Schedule**
 - (a) Three (3) days per week: per child—\$70.00 per month
 - (b) Five (5) days per week: per child—\$95.00 per month
 - (c) 1 Day Per Week - \$15/day
 2. **After-School Program Fee Schedule**
 - (a) Three (3) days per week
 1. First child in family- \$180.00 per month
 2. Each additional child in Family- \$125.00 per month
 - (b) Five (5) days per week
 1. First child in family- \$250.00 per month
 2. Each additional child in family- \$150.00 per month
 - (c) Per Diem Rate
 1. First child in family- \$20.00 per day
 2. Each additional child in family- \$15.00 per day
- b. **Summer Program.**
 - i. The Summer SACC Program is available to Milltown Residents and Non Milltown Residents.

- ii. There is a Summer Registration fee of forty dollars (\$40.00) nonrefundable fee per child for Milltown Residents
- iii. There is a Summer Registration fee of fifty dollars (\$50.00) nonrefundable fee per child for Non Milltown Residents.
- iv. SACC Fees shall be paid in equal monthly installments due by the 25th of each preceding month during the school year. If the due date falls on a weekend or holiday, the payment will be due by the following business day.

1. **Milltown Residents Fee Schedule**

(a) **June** - This Fee is for children who have NOT participated in the school year June SACC Program

- 1. Three (3) days per week
 - i. First child in the Family- \$150.00 per week
 - ii. Each additional child in the family- \$125.00 per week
- 2. Five (5) days per week
 - i. First child in the family- \$200.00 per week
 - ii. Each additional child in the family-\$175.00 per week

(b) **June**- This fee is for children who have participated in the school year June SACC Program

- 1. Three (3) days per week
 - i. First child in the Family \$75.00 per week
 - ii. Each additional child in the family - \$50.00 per week
- 2. Five (5) days per week
 - i. First child in the family - \$100.00 per week
 - ii. Each additional child in the family - \$75 per week

(c) **July and August**

- 1. Weekly Rate – (5 days per week)
 - i. First child in the family- \$200.00 per week
 - ii. Each additional Child in the family- \$175.00 per week
- 2. Per Diem Rate
 - i. First child in the family- \$60.00 per day
 - ii. Each additional child- \$50.00 per day
- 3. Monthly Rate- Three (3) days per week
 - i. First child in the family- \$525.00 per month
 - ii. Second child in the family- \$500.00 per month
 - iii. Each additional child in the family- \$475.00 per month
- 4. Monthly Rate- Five (5) days per week
 - i. First child in the family- \$650.00 per month
 - ii. Second child in the family- \$625.00 per month
 - iii. Each additional child in the family- \$600.00 per month

2. **Non Milltown Residents Fee Schedule**

(a) **June** -

- 1. Three (3) days per week
 - i. Each child- \$200.00 per week
- 2. Five (5) days per week
 - i. Each child- \$250.00 per week

(b) **July and August**

- 1. Weekly Rate (5 days per week)
 - i. \$250 Each child- per week
- 2. Per Diem Rate
 - i. Each child- \$75.00 per day
- 3. Monthly Rate- Three (3) days per week
 - i. Each child- \$600.00 per month
- 4. Monthly Rate- Five (5) days per week
 - i. Each child- \$725.00 per month

c. **Violations and Penalties of this Section**

- i. There will be a \$15.00 Late Fee for any payments made after the due date.
- ii. There will be a \$25.00 fee for returned checks or insufficient funds.
- iii. A penalty fee of \$15.00 shall be paid for each fifteen (15) minute period that a parent/guardian is late picking up a child after 6:00 p.m.

SECTION 3. All Ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 4. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent

jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 5. This ordinance shall take effect after second reading and publication as required by law. The fees outlined in **§8-4 Fees** relating to the School Year Program will be effective with registrations concurrent with the 2018-2019 school year.
