

BOROUGH OF MILLTOWN

ORDINANCE NO. 17-1451

AN ORDINANCE OF THE BOROUGH OF MILLTOWN, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY, AMENDING CHAPTER VII OF THE BOROUGH CODE OF THE BOROUGH OF MILLTOWN, ENTITLED "TRAFFIC"

BE IT ORDAINED, by the governing body of the Borough of Milltown, County of Middlesex, State of New Jersey, as follows:

SECTION 1. The Borough Code of the Borough of Milltown is hereby amended and supplemented so as to supplement Chapter 7, entitled "Traffic" so as to supplement with §7-41 "Traffic Signals", which shall read in its entirety as follows:

§7-41.1 Traffic Signals

Pursuant to the provisions of N.J.S.A. 39:4-140, the intersections herein described are designated as Traffic Signal Intersections. Traffic signals shall be installed as provided herein:

Intersection	Traffic Signal(s) on
Ryders Lane (County Route 617) and Washington Ave/ Tices Lane	All

SECTION 2. The intersection of Ryders Lane (County Route 617) and Washington Ave./ Tices Lane shall be controlled by a Traffic Control Signal in accordance with the As-Built Traffic Signal Plan and Timing Directive bearing the date of February 16, 2017, inspected January 28, 2017.

SECTION 3. The Traffic Control Signal installed shall be in accordance with the provisions of the Manual of Uniform Traffic Control Devices, Title 39 of the Revised Statutes and the New Jersey Administrative Code; shall conform to the design and shall be maintained in operation.

SECTION 4. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 5. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 6. This ordinance shall take effect after second reading and publication as required by law.
