

**BOROUGH OF MILLTOWN
ORDINANCE 23-1521**

AN ORDINANCE TO AMEND CHAPTER XIV, PARKS AND RECREATION, SECTION 6, BOROUGH POOL, SUBSECTION 6.3, FEES; AND SECTION 7, RECREATION PROGRAMS, SUBSECTION 7.2, FEES; SUBSECTION 14-9 ALBERT AVENUE PARK AND BOROUGH PARK PAVILLION; SUBSECTION 14-10 BASEBALL FIELDS OF REVISED GENERAL ORDINANCES OF THE BOROUGH OF MILLTOWN, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY

BE IT ORDAINED by the Borough of Milltown of the County of Middlesex and State of New Jersey that the Revised General Ordinances of the Borough of Milltown be amended as follows:

Section 1. Chapter XIV, Parks and Recreation, Section 6, Borough Pool, Subsection 14-6.3, Fees, of the Revised General Ordinances of the Borough of Milltown is hereby amended as follows:

e. *Non-Annual Programs.* Any programs or events not run on an annual basis by the Department of Parks and Recreation shall be at a fee established by use of the following equation: Cost of Program (based on minimum participation rate) + Administration Fee (10% of cost; not to exceed \$25)

Section 3. Chapter XIV, Parks and Recreation. Section 7, Recreation Programs, Subsection 14-9, Albert Avenue Park and Michelin Field Park, is hereby deleted and the following inserted in its place and stead:

§14-9 ALBERT AVENUE PARK AND BOROUGH PARK PAVILION.

§14-9.1 Fees. The following fees are established for the rental of Albert Avenue Park or the Borough Park Pavilion:

§14-9.2 General Rules and Regulations. General rules and regulations for the use of Albert Avenue Park or Borough Park Pavilion shall be established by the Director of Recreation with advice from the Recreation Advisory Committee and approved by the Borough Council.

Section 4. Chapter XIV, Parks and Recreation, Section 7, Recreation Programs, Subsection 14-10, Baseball Fields, of the Revised General Ordinances of the Borough of Milltown is hereby added as follows:

§14-10 BASEBALL FIELDS.

§14-9.1 Fees. The following fees are established for the rental of baseball fields in the parks within the Borough:

The foregoing fees shall not be prorated in the event the use of a baseball field is for less than an entire day.

§14-9.2 General Rules and Regulations. General rules and regulations for the use of baseball fields shall be established by the Director of Recreation with advice from the Recreation Advisory Committee and approved by the Borough Council.

Section 5. Each clause, section or subsection of the ordinance shall be deemed a separate provision to the intent that if any such clause, section or subsection should be declared invalid, the remainder of the ordinance shall not be affected.

Section 6. All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed as to the extent of such inconsistency.

Section 7. This ordinance shall take effect immediately upon adoption and publication according to law.
