## BOROUGH OF MILLTOWN NOTICE TO BIDDERS

Notice is hereby given that separate sealed bids will be received by the Borough Council of the Borough of Milltown, Middlesex County, New Jersey for the **Municipal Pool Snack Shack Concessions** as more particularly described in the Bid Specifications and Bid Proposal Forms. All bids may be mailed in or delivered to the Borough Clerk, 39 Washington Ave. Milltown, NJ 08850. Bids will be opened and read in public at the Milltown Municipal Building, 39 Washington Ave. Milltown, NJ 08850 on April 11, 2017 at 10:00AM. No bids will be received after the specified time and date.

Specifications for the aforesaid contracts are on file in the Borough Clerk's Office, Municipal Building, 39 Washington Ave., Milltown, NJ 08850 and copies thereof and of the form of proposal may be obtained during regular business hours by prospective bidders upon application to the Borough Clerk.

Bids must be made on the standard proposal form(s) in the manner designated therein and required by the Specifications and must be enclosed in a sealed envelope bearing the name and address of the bidder and clearly labeled **"BID for Municipal Pool Snack Shack Concessions"** on the outside of the envelope. Please include one original, one copy and one digital copy of the bid. All envelopes shall be addressed to the Borough Clerk of the Borough of Milltown. Each bid must be accompanied by a certified check, cashier's check or bid bond in the amount of 10% (ten percent) of the amount of the bid and a copy of a valid Business Registration Certificate.

The Borough Council of the Borough of Milltown reserves the right to waive any informality in bidding and the right to reject any or all bids if deemed to be in the best interest of the Borough to do so, and reserves the right to hold the bids and proposal guarantees of the 3 (three) lowest regular bidders for 60 (sixty) days before making an award of contract and each bidder agrees that he will not withdraw the bid for that period of time.

Bidder is required to comply with all applicable Laws and Regulations including P.L. 1975, C.127 (Affirmative Action), P.L. 1999, C.238 (Public Works Contractor Registration) and P.L. 1963, C. 150 (Prevailing Wages), if applicable.

Bidder is required to comply with the requirements of N.J.S.A. 10:5-31 et seq and N.J.A.C. 17:27. Bidder is advised of the responsibility to comply with the provisions of N.J.S.A. 19:44a-20.13. Bidder is required to submit with its bid a valid Business Registration Certificate issued by the State of New Jersey. (N.J.S.A. 52:32-44)
